## **VIII. Workshop Items for Discussion**

- A.** The City Council will consider a resolution temporarily suspending the enforcement of Section 210.920 of the Poplar Bluff Code of Ordinances, relating to the discharge of a firearm/bow within the City limits of the City of Poplar Bluff, for the limited purpose of allowing the removal of destructive animal crop invaders, in cooperation with the Missouri Department of Conservation.
- B.** The City Council will consider a recommendation from the Municipal Utilities Advisory Board to approve two amendments to the FY 2023 Budget.
- C.** The City Council will consider amendments to the Code of Ordinances, Section 435 entitled "Medical Marijuana Facilities" and Section 405 entitled "Zoning Regulations" and adding a new Section 436 entitled "Recreational Marijuana Facilities".
- D.** The City Council will consider a recommendation from the Planning and Zoning Commission to deny a request to vacate a 12' x 75' portion of alleyway lying west of 1109 N. 10<sup>th</sup> Street and east of 1019 Harper Street running east to west between North 10<sup>th</sup> Street and North 11<sup>th</sup> Street; the applicants are Jasmin Dugger and Belinda Perry.
- E.** The City Council will consider a petition for the annexation of property located at 3387 Kanell Boulevard and owned by Mr. George Milner.
